THIS DEED OF THE CHARITABLE TRUST executed on this day of 09 January, 2018 (Two Thousand Eighteen).

## IN BETWEEN

excluded by or repugnant to the subject or context be deemed to include his  
heirs executors, administrators, representatives & assigns) of the **OTHER PART**

**WHEREAS** the Trust is being formed for the upliftment of the society  
with Educational and social aspect in respect of Non - Profit making view and  
expansion of the wish to build up a new era of Educational Horizon.

**AND**

**WHEREAS** the Trustees above named on consideration of the fact that the  
unemployment problem in West Bengal as well as in India is increasing day by  
day in a big way and the Mechanism for promotion of employment and self-  
employment opportunities is not coming up to cater the need of the time and the  
society.

**AND**

**WHEREAS** the main focus of the trust shall be to develop, organize, run and  
maintain school, college, university, research institute (National and alien),  
Institute for higher education, environmental development, Institute on climatic  
change, disaster management, Vocational Institute for multipurpose training  
with outlet, Gardening for Medicinal Plants, Hurbal Production Unit, Ayurvedic  
Hospital, Automobile Training Center, Garments Factory, Biodiversity Museum,  
Cold Store, Sugar Factory, Sugar Molasses Factory, Beakery, Food Processing  
Unit, Self Help Group for Men and Women seperately, Banking sector for the  
poor, Credit Co-Operative Society for the betterment of the society.

**WHEREAS** the Credit facility without interest, Credit facility with interest, professional and technical Training facility for minorities, environmental refugees and under privileged class and also facility for Marketing outlet for marginal craftsmen and artisans for the removal of such backwardness is completely absent in West Bengal;

**AND**

**WHEREAS** the trust shall organise its capacity to work with NABARD, CAPART, KHADI VILLAGE & INDUSTRY, KHADI COMMISSION, SSI, PRIVATE BANK, NATIONAL BANK, NATIONALISED BANK, FUNDING AGENCY-, DONNER, ECB, FOREIGN FUND and any other loan, help, assist to take or to give ( if passion arises) for the sake of the trust.

a) EVANGEL PLAYSCHOOL

b) EVANGEL PUBLIC SCHOOL

c) EVANGEL SCHOOL OF EDUCATION

d) EVANGEL COLLEGE OF EDUCATION (B.ED )

e) EVANGEL COLLEGE OF HIGHER EDUCATION (M.ED)

f) EVANGEL COLLEGE OF SCIENCE

g) EVANGEL COLLEGE OF ARTS

h) EVANGEL COLLEGE OF NURSING

i) EVANGEL INSTITUTE OF TECHNOLOGY

j) EVANGEL COLLAGE OF MEDICAL SCIENCE

k) EVANGEL HOSPITAL

l) EVANGEL RESEARCH INSTITUTE

m) EVANGEL UNIVERSITY

**AND**

Security Market (NSE, BSE, Comodity) from perior permission of NSDL & SEBI, set up construction for housing complex, bridge, plants and make TRAINING

CENTRES for technical, medical and professional courses should be established and administered for promoting employment and self-employment opportunities and for that end the TRUSTEES, whose names and address given above, are desirous of establishing this. TRUST for the objects and purpose mentioned hereunder and for the said objectives in view they have already contributed a sum of Rs. 5,000/- (Rupees Five thousand only), which do form the nucleus of the property of the Trust;

AND

WHEREAS the Trustees have framed a scheme detailed hereunder for the Constitution of the Trust and carrying out the objectives of the Trust. NOW THE DEED OF DECLARATION OF TRUST WITNESSETH :

**1. NAME AND OFFICE OF THE TRUST:**

- a) The name of the Trust:- **EVANGEL CHARITABLE TRUST**
- b) The Office of the Trust shall be located at Vill and P.O- Dakshin Chatra, P.S.- Baduria, Dist-North 24 Pargarras, Pin-743247, West Bengal, but the Trustees shall have the power to shift the Office to any other place in India or open local Office at places deemed necessary.

**2. INTERPRETATION :**

- a) 'Trust' means the Trust created by this Deed, Viz.
- b) The 'Board' shall mean the Board of Trustees created by the Deed.
- c) 'Trust Property' shall include every kind of property movable and immovable owned by the Trust and mentioned in account books and other documents in the custody and control or that ought to be in the custody and control of the Trust.
- d) The trustees may amend the columns, articles, views, objects, etc. in addition with the principal deed in principally for the betterment of the Trust Property by the meeting Resolution of 2/3 of the Trustees signature.
- n) Amendment of Trust deed shall not rectification or deductible. Once decision is being taken, it will be addition with the previous part

**3. AIMS AND OBJECTS OF THE TRUST :**

**A) The main objects for which the Trust is established are :**

I) To promote economic, social, educational and general welfare of the people in general, minorities and economically backward section of the society, in particular and in specially for the MUSLIM MINORITIES, SC, ST, OBC communities also particular the maintaining tuition with Article 30(1) and to get exemption from such barrier and bondage of the concerned body.

II) To create fund provide interest loans and assistance and refunding deposit to the entrepreneurs, business persons, cultivators, students, depositors and general people with or without security under mutual terms and conditions agreed upon to facilitate Muslims and under privileged people;

III) To establish, acquire, takeover, start, run organise, maintain and manage Polytechnics, Industrial Training Centers, Medical Technician Training Centers, Crafts Training Centers, Business, Professional and Management Training Courses, Schools, Colleges, Libraries, Children Sponsorship programme, Hospitals, Ayurvedic, Homeopathic, Indo-Allopathic Clinics door to door, Nursing Homes, Hostels, Boarding Houses, Housing Complex, Housing Colony and also Training and Production Centers for the benefit of the minorities and weaker sections of the society;

IV) To produce feature film, T.V. serial in Bengali, Hindi and other regional language for the development of the educational sector and takeover, acquire, setup, organise, start, run, maintain and manage Cooperative Societies, Sales Emporia, Departmental Show-rooms and other business for the welfare of marginal Craftsmen, Artisans, Traders, Cultivators of Minorities and other backward classes;

V) To Collect donations, Subscriptions, grants, deposits and service charges to create fund for the Trust and especially to run the credit and Deposit Schemes of the Trust;

VI) To Act in such a way that the Trust hereby established shall always retain the status of one such trust to which the provisions of section 12A, FCRA, 80G/ 35 AC/ 10(23C)IV/V/VIA of the income Tax Act, 1961 or any modification replacement or thereof for the time being in force shall apply so that any donation or contribution thereto is recognized as eligible for exemption or relief from tax in the hands of the donor

**B) Objects incidental or ancillary to the attainment of the main objects are :**

- a) To create awareness and implement the spirit as enunciated in the Prime Minister's 15-Point Programme for the welfare of the Minorities;
- b) To create and work in conjunction of various projects with Governmental Authorities and/or the upliftment of Organizations in India or Abroad for the upliftment of Minorities and Weaker sections of the Society;
- c) To assist in career planning and developing the self-employment tendency and motives of unemployed youths, students and general people of the country, specially minorities and backward classes;
- d) To arrange work-shop, training programs, meetings and study circles for the development ventures and agricultural and agro-industries;
- e) To arrange survey, study and research on cottage and small scale industries, crafts and artisans various professional and agricultural groups;
- f) To publish and manage study and research material, books and booklets and such other media materials for disseminating the information and for the propagation of the objects of the society;
- g) To establish and manage employment information centers for collecting information on vacancies in various commercial and industrial establishments and organizations who are in need of suitable hands and introduce the job-seekers with these organizations;
- h) To award certificates, scholarship, extend financial assistance and also interest-free loans to the deserving students for technical, medical, professional, religious and higher studies and also to go abroad for this purpose;
- i) To impart education with up-to-date knowledge of latest developments within all fields of human activities and to make original contributions to the refinements, enhancements and increase of such knowledge, application of the same to moral, material and spiritual progress of women and men weaning him/her from the use of knowledge for destructive and retarding purposes;
- j) To lay emphasis on the universal and human aspects of the teaching of Islam and to harmonize the same with the national life;
- k) To arrange and organize lectures, debates, discussions, seminars, symposium, excursions, public meeting etc. On problems connecting the Economic, Social, Cultural and Educational of the people in general and Minorities in particular;

l) to do all other things as may be deemed incidental or conducive to the attainment of the foregoing objects;

#### **4. RAISING OF FUND AND EXPENDITURE :**

And for achieving any or all the objects to raise funds through donations, grants, loan (from any institute National or International) and contributions and to obtain and receive deposits and loans from individuals, associations firms or any institutions whatever and to invest and deal with the money and funds belonging to the Trust not immediately required in such manner as may from time to time be determined by the Board of Trustees Subject to the law of the land, and to take on lease or purchase or accept by way of gift any land, building or any other property both movable and immovable and to remunerate any person, Firm or Institution for services rendered to the Trust in any capacity and to pay out of the funds of the Trust all costs, charge, expenses, incidental to the establishment, registration and advertisements of this Trust and to adopt and take such other lawful means as may be incidental and conducive to the accomplishments of all or any of the above objects and shall also receive grants and donations from Foreign Governments, Institutions or Agencies and Individuals according to the prevailing law of the land. All types of collecting funds and creating assets must be in the status of nonprofit making aims.

AND for achieving any or all the objects to raise funds through Bank Loan (With Interest), Bank Loans (Without Interest from religious sector only), Bank Loans from Newly Projects of the Trust, Term Loans for the benefit of the development of the building and other beneficiary part of the trust from any International Bank, Nationalized Bank, Private Bank, Corporate House, Foreign Fund, Individuals according to the prevailing law of the concerned ground. All types of collecting funds -from loans and creating assets through innovative and beneficial projects must be in the status of Profit-Making aims as well as the projects must help the society and able to refund the loans to the loaners.

#### **5. CONTROL OF THE TRUST :**

The Properties and funds shall vest in the Board of Trustees constituted by persons executing the Deed of Trust. The number of members of Board of Trustees shall not exceed 15 (Fifteen) if there are vacancies at the time of execution of this deed the same can be filled by co-option by the Board of Trustees.

#### **6. OFFICE BEARERS OF THE TRUST :**

Provides that the Board of Trustees is authorised to create any other office bearer and elect other office bearers to fill up the post from among the Trustees.

The above office bearers shall be elected from among themselves by a majority of the Trustees at a meeting convened for the purpose.

#### **7. QUORUM :**

To take any decision board meeting is mandatory with the representation of all of the settlers. The members shall also take part of the decision with the policy making of the proportionate law as stated in the part of settlers. The law of quorum will not be activated separately.

#### **8. (A) VACANCIES :**

A vacancy shall arise among the trustees in the following case :

- a) When a trustee dies ;
- b) When he resigns his office as a Trustee ;
- c) When he is absent from three consecutive meetings of the Board, unless the Board records condoling such absence in the minutes of the meetings of the Board of Trustees for substantial cause;
- d) When he becomes insolvent;
- e) When he is convicted of any criminal offence involving moral turpitude;
- f) When he acts or does anything detrimental to the interests of the Trust;
- g) medical evidence when he is declared physically or mentally unfit by a resolution of the Board at a meeting convened for the purpose. In case of any vacancy arising among the trustee new trustees shall be nominated and

appointed and such persons shall be of sound mind, who are not employees of the Trust, who shall be above eighteen years of age and who shall subscribe to the objects of the Trust. The Board of Trustees then by a 2/3rd majority of the existing members attending the meeting convened for the purpose, shall fill up the vacancies arising in the Board of Trustee and also increase and include more trustees.

8. (B) NOMINATION: A nominee shall be inputted in place of the Settlers trustees to perform the activities of the said trustee as per the VACANCY'S rule. The Trustees are not the functioning authority, they can be resolved through resolution and there is no system for voting authority against the settlers. In case of nomination, personal law of Islam is not activated here.

9. TERMS OF OFFICE: The Board of Trustees shall elect the office bearers, from among themselves within a month of the formation of the Trust they shall remain in office for 5 Years. The Board will elect office bearers for the next term within a month of the expiry of the term.

10. POWER OF TRUSTEES:

The Board of Trustees shall have the following power:

a) To call for and collect and receive funds and such funds may be utilized by them for such purposes and objects of the Trust as they deem fit.

b) To accept and receive contributions for the expansion and betterment of Trust projection in the form of any grants, donations, subscriptions from the willing bodies and in the form of loans either in interest free or in interest collecting form any International Bank, National Bank, Corporate Bank, Individuals or any firms, either in on projects profile or the mortgage of the Trust Property, trustee Property, Trustee's relative's Property (by willing with Notary affidavit), Any individuals (willing to develop the Trust by Notary Affidavit) by the choice of the Trust Body.

c) To acquire movable and immovable property by purpose or otherwise.

d) To erect or cause to be erected building or buildings, equipment's and machinery for the use, benefit and attainment of the objects of the Trusts.

e) To sell, transfer, exchange, convey and alienate or mortgage movable and immovable properties belonging to the trust for the expansion and betterment of the Trust through any positive sign as prospect of the Trust.

- f) To manage, administer and control properties and all assets of the Trust directly and all institutions under or connected with the trust.
- g) To demand, call for and realize money and other assets due or belonging to the Trust and issue receipts and vouchers for the receipt of the same.
- h) To employ necessary staffs for the management, administration and running of the trust in general and for the institutions in particular and for the purpose of carrying out the object of the Trust on such terms as may appear proper to the Trustees and to delegate and to allot to such staff from time to time such powers and duties as may be necessary in the usual course of business.
- i) To appoint from time to time and at any time to suspend, dismiss, remove or discharge and any person under their control including clerks, accountants, and to re-employ them with such powers and duties and upon such terms either by giving one month notice or by giving one month salary as the Board of Trustees shall think proper.
- j) The Board shall have full powers to make amend, delete or rescind rules and byelaws of the Trust.
- k) To do all acts and things which are connected with the administration of the Trust in general and of the institutions in particular and which are deemed by the Trustees to be in the best interest of the Trust and are desirable.
- l) To take any final decision for any aspect of the trust the Settlers are mandatory. In absence of the Settlers, his/her nominee or worries will act the same.

#### 11. FUNCTIONS OF THE OFFICE BEARERS:

##### PRESIDENT:

The PRESIDENT is empowered to take decisions on urgent matters, but such decisions should be approved by the Board within a period of 30 days. The PRESIDENT will preside over the meetings of the Trust and conduct the proceedings, the PRESIDENT in his own discretion or by the request of one-third of existing members can call for a meeting of the Trustees. The PRESIDENT shall carry out all the resolutions of Trust and for that purpose he shall have power to insure necessary expenditure from out of the funds of the Trust, subject to a maximum of Rs. 10,000/- (Rupees Ten Thousand) only and anything in excess of Rs. 10000/- (Rupees Ten Thousand) is to be incurred with the sanction of the Board. The PRESIDENT is empowered to delegate such

powers to the SECRETARY or any other members of the Trust as he may deem fit.

**SECRETARY:** under the direction of the Board of Trustees the secretary shall carry out correspondence with the proper authorities on behalf of the Board.

The SECRETARY of the Board of Trustees, elected under the control and supervision of the Board, shall conduct and manage all the affairs of the Trust, its properties and institutions, sign papers and carry on correspondence on behalf of the Trust, and shall be responsible for the safe custody of records of the Trust, and the keeping of proper accounts thereof. He shall also perform such other duties as may be entrusted to him from time to time by the Board provided that in the absence of the SECRETARY, PRESIDENT, The Treasurer or any other Trustee especially authorized on behalf of Trust and do all or any of the duties relating to day affairs of the Trust. The SECRETARY shall attend to the correspondences and day to day affairs of the Trust. The SECRETARY shall carry out all the resolutions of Trust and for that purpose he shall have power to insure necessary expenditure from out of the funds of the Trust, subject to a maximum of Rs. 20,000/- (Rupees Twenty Thousand) only and anything in excess of Rs. 20000/- (Rupees Twenty Thousand) is to be incurred with the sanction of the Board. He shall have the custody of the correspondence and other books relating to the affairs of the Trust.

**TREASURER:**

The Treasurer of the Board of Trustees, elected under the control and supervision of the Board, shall conduct and manage all the affairs of the Trust related to Accounts & Finance, Properties & Wealth could carry and conduct with his/ her self custody and placed only in general meeting or invitation of Trustees with group discussion.

**TRUSTEES:**

The Trustees herewill act as per the Indian Trust Act, 1882 to make a role of ordinary Trustees.

**12. APPOINTMENT OF EMPLOYEES :**

The Board shall have also power to employ necessary staffs for management, administration and running of the Trust in General and of the Institution in particular on such reasonable salaries and remunerations and on such terms as may appear proper to the Trustees for managing the affairs of the Trust and the

Institutions and for the purpose of achieving of the objects of the Trust. They may be allotted or entrusted with such duties and responsibilities as the Board would deem fit.

It shall be competent to the Board to remove the staff referred above without assigning any reasons thereof, one month notice or payment of one month's salary.

**13. RECEIPTS OF CONTRIBUTIONS ETCETERA AND BANK ACCOUNTS :**

A. All the monies should be received only on account of or in the name of the Trust and receipts should be issued under the seal of the Trust and must be signed by the TREASURER. The TREASURER shall be responsible for full and complete accounting for all the receipts and disbursements of the monies or the other properties received for the Trust. No money or property shall be received or used except for the purpose and objects of the Trust. The Trust may open the bank account in any nationalized or private bank in respect of sayings and current account respectively. The Bank Account shall be operated by any two of the SECRETARY the TREASURER and the PRESIDENT jointly.

B. Under this Trust Deed separate Bank Account may open in the name of the separate institute as described before and endowment or reserve fund may deposit in the name of the separate institute deemed necessary.

**14. BOARD MEETING :**

A meeting of the Board shall be held ordinarily at least once in 6 months or earlier on the requisition of all the settlors Trustees to consider the affairs of the trust and all the proceeding of the meeting shall be recorded in the minutes book to be preserved by the Secretary on behalf of the Trust. Notice of every meeting of the Board together with the Agenda shall ordinarily be given by the Director or Conveners to all the Trustees at least fifteen clear days before the proposed date provided that in case of emergency there will be no time limit for serving the notice.

If it was delivered to the Trustee personally or if such notice as issued to the last postal address furnished to the office of Trust by the Trustee concerned and (i) ..... posted within a reasonable time so as to presume that the notice should have reasonable time so as to presume that the notice should have reached the address (Trustee) in the due course; or (ii) served on any such person of the said address of the Trustee concerned.

The PRESIDENT of the Board of Trustees shall preside at all meetings of the Board of Trustees. In the absence of the PRESIDENT of the Board of Trustees in the meeting, the Secretary shall preside. In the absence of both, the Trustees present therein may elect a PRESIDENT from among themselves to preside over the meeting.

Every question which shall arise at any meeting of the Board shall be decided by a majority of votes of the Trustees present and in case of equality of votes the PRESIDENT of the meeting shall have a second or casting vote, but in no other event shall any Trustee have more than one vote and there shall be no vote by PROXY. The Proceeding of every meeting shall be entered in the minutes book maintained for the purpose and signed by the Trustees present at the meeting. In the absence of both, the Trustees present therein may elect a PRESIDENT from among themselves to preside over the meeting.

iv) For the expansion of the Trust, its works, activates, objectives and impressiveness the immovable properties may be mortgaged, altered, exchanged, transferred for the sole purpose and to collect fund through Bank Loan and others by the Board in its meeting by a resolution passed by 2/3 majority of the Trustees present.

#### 16. SUITS AND LEGAL PROCEEDING:

The Board or any one or more of the Trustees may apply for advice or the directions to the Court as occasion may arise. The Board of Trustees may sue or to be issued in the name of the Director of the Board. The Board may be a resolution passed specially or generally in that respect at any time and from time to time, authorize any of the Trustees by power of attorney or otherwise the SECRETARY of the Board of represent Board of Trustees i.e. all Trustees.

- i) To institute, conduct, defend, compound, withdraw or compromise, adjust, refer to arbitration or abandon any legal or other proceedings, claims or disputes, or against the trust or trustees or against its officers or employees concerning the affairs of the trust and to sign and verify vacillates, complaints, statements, affidavits, and other-proceedings before all courts, tribunals and other Government authorities both Central and State.
- ii) In entering into any agreement or contract or in executing and/or registering any documents.
- iii) Generally in doing and performing any act, deed, matter of thing, whatsoever which has to be done, executed and performed by the Board of Trustees or Trustee as the case may be in the relation to any property of the Trust or in or about concerns, engagements, business affairs and matters of the trust and or of the Board, and/or trustees/trustee as is/are such principal/principals.
- iv) The Board may take any other step it may deem fit to meet any contingency affecting the trust in any legal proceeding or any other matter.

#### 17. OFFICE YEAR:

The official year of the Trust shall be first April to thirty first march of each year.

#### 18. WINDING UP OF THE TRUST :

The Trust is revocable. The Trustees shall have power to wind up the Trust activities. The property, funds and assets of the Trust that may remain after full satisfaction of the liabilities of the Trust will be transferred paid and handed over to any other trust, society or institution established for achieving similar aims and objectives provided that;

- i) Notice of such meeting is served on all existing Trustees;
- ii) Such meeting is attended by at least 3/4 of the existing Trustees;

iii) Such decision or resolution is carried by the votes of at least 4/5 of the Trustees present.

iv) At the time of meeting of the Board of Trustees, there shall exist all the minimum Trustees in office of not less than 5(five) Trustees. There should be no vacancy existing on the minimum number Board of Trustees.

#### 19. AMENDMENTS TO THE SCHEME :

It at any time is found that alteration in any of the provisions of this trust or scheme for the purpose of effective achievement of the objects of this trust are imperative and very essential, then the board shall approve of such alteration by a resolution passed, in its meeting, and thereafter the modification shall be come part and parcel of the terms, conditions and provisions of this trust and of this scheme.

The board may at any time and from time to time make, amend delete and rescind rules and bye-laws for the conduct of its business, for the control, management and administration of the trust made under this trust and for carrying out the objects of the trust relating to any matter under this scheme, provided that such rules and bye-laws shall not be inconsistent with or repugnant to any of the provisions of the scheme of the trust.


